### Meeting Highlights – May 15, 2020

This conference Call Meeting was conducted via ZOOM

Press release announcing Dr. Kevin James as the 19<sup>th</sup> President of Morris Brown College issued on May 15, 2020.

Wesley Peachtree Group's Senior Partner and the Lead Auditor provided tentative drafts of the audit reports for fiscal years 2016, 2017 and 2018 to the board's Audit Committee for review on April 6, 2020 with a plan to provide the 2019 financial statement draft shortly thereafter.

Proposed Health and Benefits offerings from Kaiser Permanente and Anthem Blue Cross were presented for consideration. Kaiser Permanente is recommended for Medical Health Coverage with Anthem Blue Cross providing Dental, Vision, Disability and Life coverage.
